Dear Friends of BOEC,

This past year, our 41st, BOEC served 2,434 students on 7,615 programming days in our summer and winter programs. Adults and children with a wide array of abilities and adaptive needs came to us from all over the country and around the world.

The Adaptive Ski and Ride Program conducted 3,429 lesson days, emphasizing the critical importance of outdoor activities in the lives of our participants and the joy that they experience through skiing and riding. Many longtime participants returned, including Summit High School, Aurora Mental Health and U.S. Association of Blind Athletes. It was an extremely busy summer for us as well. The Wilderness Program conducted 4,186 program days for 1,342 adventurous individuals, many coming on customized group programs. Multiple-day camps included a number of returning and new agencies, including Brain Injury Alliance, Children's Hospital, Serendipity (out of Houston) and Boulder Mental Health.

It was a rewarding year for all of us, continuing the growth and success BOEC has enjoyed for over a decade. As one intern put it: *"We all get together and create our own little world...I came as an individual and leave as a family...You allow me to be weird and allow me to be goofy. You inspire me."*

Many thanks to all of you in the BOEC community who inspire. It is indeed a village effort that includes staff, interns, volunteers, board members, donors, community partners, agencies, parents, guardians and, above all, our students who are determined to forge a better life for themselves through adventure!



He is a respected expert in the adaptive snowsport network nationwide serving as an adaptive coach with the US Paralympics.

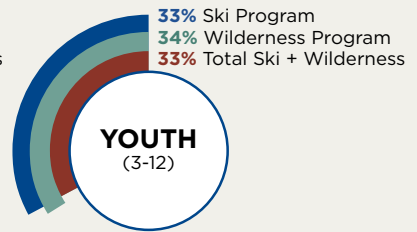
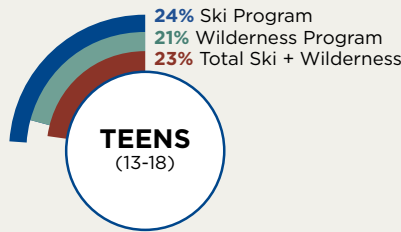
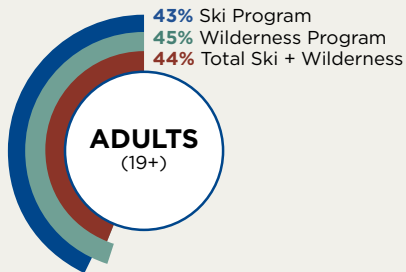

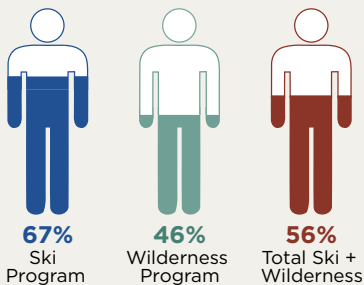

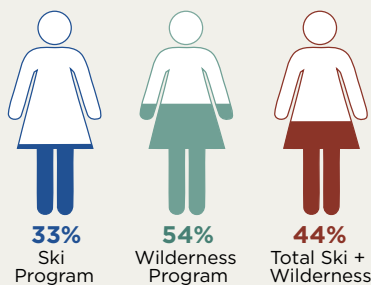

The Year in Highlights

PROGRAM

Brain Injury Alliance of Colorado returned to BOEC for six multi-day retreats this summer. These retreats are for adults with brain injury and feature all of our primary activities—rafting, cycling and ropes course—as well as creative arts & crafts and a memorable costume party. We also conducted a winter retreat featuring alpine and Nordic skiing.

BOEC's Heroic Military Program delivered 1,001 program days to 147 veterans with disabilities, along with 86 family members. A total of \$104,000 in restricted grants and contributions allowed these deserving families to participate for little or no cost to them. Our trips strive to provide opportunities for veterans to regain confidence in themselves and to find connections both with other veterans and their loved ones. We delivered five multi-day summer courses, including three river trips and two Griffith Lodge mountain retreats. The Adaptive Ski Program delivered another five courses, including Semper Fi, The Not Forgotten Association in London, Wounded Heroes Family Ski Week, and two very successful week long events—Adaptive Ski Camp at Keystone and the Hartford Ski Spectacular. One participant this summer said, *"I have not camped in over 10 years because of the Army and this was an incredible way to reinvigorate my love of the outdoors."* Another stated, *"This river trip was life inspiring. It showed me I am not that different than my peers and I can actually do the things I did before I was injured."*

For a second year, we served 12 students from the Delta Gamma Center. They are an agency serving youth living with visual impairments and autism. One memory from a BOEC staff recalled her experience watching a young girl rock climbing for the first time. *"The first climb was extremely challenging for her and she screamed but kept climbing to the top. After adjusting to the new environment,*

she was able to enjoy the experience and completed multiple routes during the day."

We served 136 local students living in Summit County from 17 different programs throughout the year. A new addition were four single day programs with Timberline Adult Day Care that included skiing, adaptive cycling and a ropes course day. The program focused on increasing self-esteem, independence and communication skills.

"The experiences BOEC provided myself and my family were both fun and new since my TBI. I was able to do all of them even though my family wasn't sure I could thanks to BOEC staff and interns! They really made us all feel comfortable and confident in our abilities!"

INTERNS

BOEC brought an amazing group of interns into the program this year, training 14 interns this past winter and 12 this summer. The interns not only bring valuable skills and insights into our courses, they bring an infectious energy and optimism to all who work with them. Over the past 41 years, the Internship Program has graduated over 570 talented professionals, many of whom have gone on to work in the adaptive outdoor education field around the country and the world.

VOLUNTEERS

Over 250 volunteers put in nearly 20,000 hours in support of BOEC this year. Most volunteers worked as assistant ski instructors, providing much needed support to our students, many of whom need two to three staff in order to ski or ride. Others helped with wilderness summer



programming, primarily in rafting and adaptive cycling, and others helped on special events. We could not do what we do without the enormous amount of time and energy given by the volunteers. Many thanks to this devoted crew.

FUNDRAISING

BOEC raised \$650,000 this year to support our operations and another \$195,400 for the capital campaign. We delivered our four signature events—Banff Mountain Film Festival, Breckebeiner Nordic Ski-a-thon, Cinco de Mayo celebration and Keystone Golf Scramble—to both raise funds for our programs and promote BOEC to the community. We continued to work to keep BOEC

as affordable as possible, both by subsidizing programs through contributions and by awarding scholarships to those in need; this year we awarded over \$240,172 in tuition assistance.

CAPITAL CAMPAIGN

As we closed this fiscal year and enter the 2018, we are nearing the end of our *Securing the Future Capital Campaign*. This year we raised \$195,400 bringing the cumulative total to over \$2.1M—95% of the way toward our goal of \$2.2M. We expect to raise the final \$60,000 early in 2018.

The campaign will impact several critical needs of BOEC:

- Create a new field staff housing facility
- Upgrade the administrative and logistics support facilities
- Expand/improve program activities and support, such as ropes course, river access and vehicles
- Increase scholarship endowment for low-income students.

We have completed a number of program upgrades and we broke ground on the staff housing, warehouse expansion and office upgrade in the spring of 2017. We owe a huge thanks to all of our donors (see full list under *Contributions*) and a special acknowledgement to our key partners—Carl and Caroline Swanson Foundation for their seed gift of \$250,000, Peter Joyce and DJ Schappert at Rockridge Building and Jon Gunson of Custom Mountain Architects for taking on the building project pro bono, Town of Breckenridge for their massive in-kind support, and Tim Casey for his leadership and contributions to the campaign.

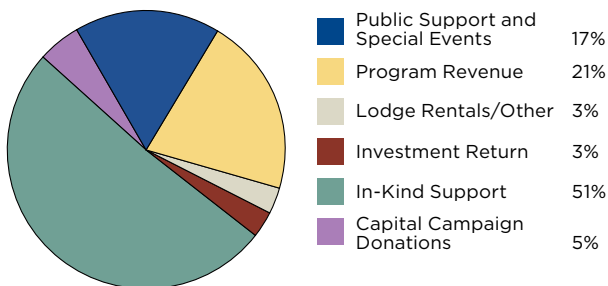

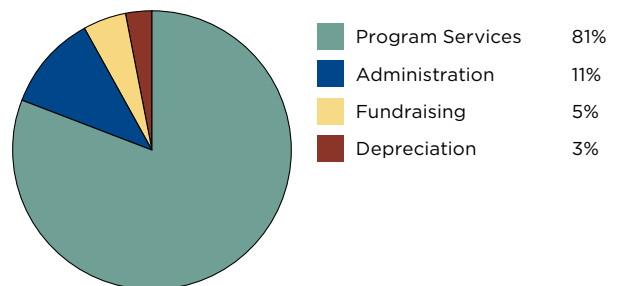

I still wanted to do that with Scott but I started thinking about what sports could we do and how could we modify them to allow Scott to participate—the list got narrow and I realized I was thinking in terms of “What could we manage to support Scott in?” The ski experience with BOEC was one in which I couldn’t keep up with Scott. I realized that instead of me ‘supporting Scott and making sure he could participate’ there was a whole world available to him where I had better get in shape myself or he’d be leaving me in the dust! That subtle shift is so profound to me, I am so excited to see that there are so many opportunities available to him again.”
